# INTRODUCTION

THE AVONITE® USER MANUAL AIMS TO GATHER THE MOST IMPORTANT INFORMATION ABOUT OUR PRODUCTS. THIS MANUAL IS MEANT TO BE USED AS THE PRIMARY REFERENCE DOCUMENT WHERE ALL IMPORTANT INFORMATION IS GATHERED IN ORDER TO EASE THE ORDER PROCESS. Depending on what you need, Aristech Surfaces LLC offers four different processes to order AVONITE<sup>®</sup>.

The stock from Europe offers the advantage of proximity with short delivery timing and a limited minimum order quantity.

With a longer delivery time window, the stock from the USA offers a slightly wider diversity of product with a more competitive price, than when you buy your product from the European stock.

With the **RIGHT SIZE** Programme, you can get special dimensioned product for exactly the same price per sqm as a stock item in 18 different dimensions for 12 mm thicknesses. For these, a minimum order quantity is required as we still need the time to produce the sheets.

And finally, for all the items that are not part of the RIGHT SIZE Programme, typically 3, 6 and 9 mm or more exotic dimensions, you would have to go through the CUSTOM SIZE Programme.

# **ORDERING PROCESS**

THE PURCHASE ORDER IS A WRITTEN COMMERCIAL DOCUMENT ISSUED BY THE BUYER TO THE SELLER, COMPRISING OF CONTAINING TYPES, PRICES, QUANTITY, QUALITY AND TERMS OF THE GOODS TO BE DELIVERED. ON THE OTHER HAND, THE SALES ORDER IS A CONFIRMATION DOCUMENT PREPARED BY THE SELLER AND SENT TO CUSTOMERS BEFORE THE DELIVERY OF SPECIFIED GOODS, AT THE CUSTOMER'S PLACE.

## THE PROCESS

- The buyer sends his Purchase Order to csorders@aristechsurfaces.com. No Sales Order will be sent back without a Purchase Order.
- 2 As soon as the Purchase Order is saved into Aristech Surfaces' system, the buyer receives an automatic confirmation of the Sales Order.
- **3** From the moment where the Purchase Order is placed, it can still be amended during:
  - a the next **24 HOURS** for a picking from Aristech Surfaces' European warehouse,
  - **b** the next **48 HOURS** for a picking from the USA. <u>No change is possible after these delays.</u>

The "Sold to" address must include the distributor's name and address.

#### **(5)** Product Information

- a Colour name, colour reference and dimensions of the Sheets
- **b** Colour name and colour reference of the Adhesives

- Acrylic Elements Please refer to the Shaped Acrylic Elements User Manual p. 4-13, for c.





#### CHARGE:

- Rainbow pallets and "individual sheets" order out of the EU warehouse are subject to a \$75 surcharge per pallet.
- Rainbow pallets order out of the KY USA warehouse are subject to a \$200 surcharge per pallet and are only possible for sheets of 12 x W. 762 x L. 3658 mm in either 3 colours and 5 sheets per colour OR 2 colours 1 colour in 10 sheets and 1 colour in 5 sheets.

# **DIMENSIONS TOLERANCES**

## **SURFACE DEFECTS**

The manufacturing process will provide a factory finish which may show superficial defects not representative of final product quality. It is important to follow the recommended final finishing steps found in the Fabrication Guide before conducting a visual inspection or colour match test.

Chip filled sheets are designed to have a random particle distribution which may lead to similar chips being grouped together. This is not considered to be a defect but is a designed aspect of the AVONITE® solid surface sheet. Chip distribution defects often appear as an area of the sheet with little to no chips and other areas with a high concentration. If colour inconsistencies such as blotches / clouding or chip inconsistencies such as washouts are found and cannot be worked out, contact our customer service.

#### **QUALITY SPECIFICATIONS**

Surface defects such as dirt, streaks, contamination, etc. can be observed either at the QA inspection station or the inspection bridge. These defects are typically not acceptable. Any one of the following defects, determined by the ISSFA-2-01 (2013) SST 5.1-00 standard specification, will cause a sheet to be classified as B grade:

#### Face Side Contamination

For a sheet to be considered defective due to contamination, it must have five or more spots of contamination that are larger than 0.1 mm<sup>2</sup> and/or a single contaminant spot greater than 0.25 mm<sup>2</sup> per ISFA-2-01 (2013) SST 5.1-00.

Exception: No more than 5 particles of 0.3 mm<sup>2</sup> or larger size each per square metre of sheet, on the below list of colours.

(9117 Kokoura, 7810 Malt, 7848 Snow Mist, 7749 Mellow, 8206 Alpine Shimmer, 7817 Harland, 7728 Relic, and other recycled product; 4310 Coastline)

Size Estimation Chart – Only use the original clear template for actual measurement.

#### · Face Side Pinholes, Voids, and/or Ripples

Any face side pinhole or void is considered defective. Other face side surface imperfections are considered acceptable if they can be removed by orbital sanding with 320-grit sandpaper.

#### Back Side Pinholes, Voids, and/or Ripples


Light porosity, such as pinholes or voids, are acceptable in the back side of the sheet. Any ripples, bumps, or divots are considered defective as is any glossy (non-sanded) area more than 0.5 mm in depth.

#### SIZE ESTIMATION CHART



This chart is for estimation of defect or other area estimation requirements. For high precision work, the spot and rectangle areas on this chart should be measured microscopically and correction factors be developed.

This chart must NOT be used to measure dirt (EBA) by methods T213 or T437.

# **COLOUR MATCH**

AVONITE® acrylic solid surface sheets are manufactured in continuous cast production cycles to reduce the variation in sheet characteristics. Different production cycles of the same product may show minor variations in characteristics, including colour. For optimal colour match, the following checks should be taken to ensure best results.

- **1** Check the product identification number printed on the sheet.
- 2 Conduct a colour match test.

#### **Identification Number**

The product identification number format will differ based on production facility.

#### Florence, KY AVONITE®

Sheets produced at the Florence, KY facility will have the product identification number printed on the side and/or bottom of the sheet and consist of nine numeric digits in the following format:



The full identification number should be identical for optimum colour match. Sheets with the same date and production line number but different batch number were manufactured during the same production cycle and should pass a colour match test.

#### **Colour Match Test**

Follow these steps to conduct a colour match test:

- 1 Cut a sample strip from the sheets intended to be used together.
- **2** Seam the samples together and polish to desired finish.
- **3** Inspect the seam for proper colour match.

#### Colour and chip inconsistency

The manufacturing process will provide a factory finish which may show superficial defects not representative of final product quality. It is important to follow the recommended final finishing steps found in the Fabrication Guide online before conducting a visual inspection or colour match test.

Chip filled sheets are designed to have a random particle distribution which may lead to similar chips being grouped together. This is not considered to be a defect but is a designed aspect of the AVONITE® solid surface sheet. Chip distribution defects often appear as an area of the sheet with little to no chips and other areas with a high concentration. If colour inconsistencies such as blotches/clouding or chip inconsistencies such as washouts are found and cannot be worked out, contact our customer service.

#### **Colour Consistency Analysis**

When feasible, the colour consistency of each production batch of material is analysed with a Colour Spectrophotometre and compared against the target CIE L\*a\*b Colour Scale values. For sheets that have marble or veining patterns, or contain large chips, the colour consistency is analysed against a Master Sample under controlled lighting conditions.

## WARPING

Lay sheet, on flat surface. If the edges of the sheet deflect up (forming a "bowl") greater than 1.5 mm in the width direction, contact customer service.

# BREAKAGE

Corner or edge chips are acceptable if the usable width and length meet or exceed the nominal sheet size.

## **PROTECTIVE FILM**

Stock items – except 3 mm thickness sheets – are delivered with a protective film.

In the case of a **RIGHT SIZE** order or a custom product order, the customer may specify if he wants the sheets produced with or without a protective film. By default, the sheets will be covered by a protective film – except 3 mm thickness sheets.

## **ADHESIVES**

#### **A** Viscosity

Resin Side to be 20000 to 35000 CPS Activator Side to be 10000 to 15000 CPS

#### B Gel time

Gel time (working time) 8 minutes to 13 minutes (room temperatures).

Fixture time (time to begin fabricating the product) to be within 20-30 minutes of adhesive application time (room temperatures).

#### C Colour consistency

Colour consistency is below 1  $\Delta E$ .

#### D Storage and shelf life

Shelf life of Solid Surface Adhesive (Part A) and activator (Part B) is 18 months. Shelf life is based on continuous storage between 12°C and 23°C. Exposure (Long term) above 23°C will reduce the shelf life of these materials. Prolonged exposure of activators, including cartridges that contain activators, above 37°C rapidly diminishes the reactivity of the product and should be avoided. These products should never be frozen. For expiry date see label.
